

Official Rules for Techthelead #OnePlusWhat Giveaway
No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning.

- 1. Eligibility:** Techthelead #OnePlusWhat Giveaway (the “Giveaway”) is open to anyone (Domestic or International), who is at least eighteen (18) years of age, who has internet access and a valid email address. Employees, independent contractors, interns, officers, directors, and agents of Sponsor, other companies associated with the Giveaway, as well as the immediate family members (spouse, parents, siblings, and children, and their respective spouses) and household members of any of the foregoing are not eligible to enter. **VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

You will receive one (1) entry for completing the following action directly from the links on the Giveaway Website: answering to Techthelead’s official question (the “Entry”). There is a limit of one (1) Entry per person during the Entry Period. Entries in excess of the allowable limit will not be acknowledged. The use of an agency or any automated system to enter is strictly prohibited and Sponsor reserves the right to disqualify any entries received through such methods, as determined by Sponsor, in its sole discretion
