

Official Rules for Techthelead GoPro Hero 6 Giveaway
No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning.

- 1. Eligibility: Techthelead GoPro Hero 6 Giveaway** (the “Giveaway”) is open to anyone (Domestic or International), who is at least eighteen (18) years of age, who has internet access and a valid email address. Employees, independent contractors, interns, officers, directors, and agents of Sponsor, other companies associated with the Giveaway, as well as the immediate family members (spouse, parents, siblings, and children, and their respective spouses) and household members of any of the foregoing are not eligible to enter. **VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

- 4. Agreement to Official Rules:** By entering the Giveaway, you indicate your full and unconditional agreement to, and acceptance of, (a) these Official Rules and (b) Sponsor’s decisions, which are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 5. Entry Period:** The Giveaway begins at 6:00 PM EET on Wednesday, December 14, 2017 and ends at 6:00 PM EET on Friday, December 27, 2017, (the “Entry Period”). Entries submitted before or after the Entry Period will not be eligible. Administrator’s computer is the official time-keeping device for the Giveaway. Entries submitted before or after the applicable Entry Period will not be eligible.

You will receive one (1) entry for completing the following action directly from the links on the Giveaway Website: answering to Techthelead’s official question (the “Entry”). There is a limit of one (1) Entry per person during the Entry Period. Entries in excess of the allowable limit will not be acknowledged. The use of an agency or any automated system to enter is strictly prohibited and Sponsor reserves the right to disqualify any entries received through such methods, as determined by Sponsor, in its sole discretion
- 7. Drawing:** After the Entry Period, Sponsor will select one (1) winner in a random drawing of all entries received. The odds of winning depend on the number of entries received.
- 8. Notification and Requirements of Potential Winner:** Potential winner will be contacted by email to the account used to enter the Giveaway within the day of the drawing. Failure to respond to the initial verification notice within twenty-four (24) hours after notification or return of verification notice as undeliverable after three (3) attempts will result in disqualification; if a potential winner is disqualified, the Sponsor will select an alternate potential winner in his/her place at random from all remaining entries received. Only three (3) alternate potential winners will be contacted. Except where prohibited, a potential winner

may be required to complete and return an affidavit of eligibility and liability/publicity release.

- 9. Prize:** The winner will receive one (1) GoPro Hero 6 camera with an ARV of 2599 lei (\$661,41 at the current exchange rate via European Central Bank).

Winner is responsible for paying any applicable income taxes and any and all other costs and expenses not listed above. Any Prize details not specified above will be determined by Sponsor in its sole discretion. Winner is responsible for paying any applicable income taxes and any and all other costs and expenses not listed above. The Prize will be delivered to Winner at the address designated by Winner. The Prize may be subject to additional terms and conditions. The Prize (or any Item) may not be transferred and must be accepted as awarded.
