

Official Rules for TechTheLead Extraordinary Tech Giveaway

No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning.

- 1. Eligibility:** TechTheLead Extraordinary Tech Giveaway (the “Giveaway”) is open to anyone (Domestic or International), who is at least eighteen (18) years of age, who has internet access and a valid email address. Employees, independent contractors, interns, officers, directors, and agents of Sponsor, other companies associated with the Giveaway, as well as the immediate family members (spouse, parents, siblings, and children, and their respective spouses) and household members of any of the foregoing are not eligible to enter. **VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**
